Pursuant to Regulation 30 and Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 (“Listing Regulations”), read with SEBI Master circular dated 11th November 2024 and in continuation to our disclosure dated 23rd May, 2025 regarding the matter [Case Reference No.: CS(COMM)1099/2024] concerning the suit instituted by Yatra Online Limited before the Hon’ble High Court of Delhi challenging the accepted trademarks ‘BookMyYatra’ and ‘BookMyYatra.com’ of Mach Conferences And Events Limited, we hereby submit that the Company has received an order from the Hon’ble High Court of Delhi.

Further to our earlier disclosure to the Exchange, as referenced above, we wish to inform you of the following development in the ongoing litigation:

*“The matter was listed before the Hon’ble Court on 22.08.2025 for pronouncement of judgment on the pending application seeking an injunction against the Defendant (Mach Conferences and Events Limited) from using the marks ‘BookMyYatra’ and ‘BookMyYatra.com’. Vide Order dated 22.08.2025, the Hon’ble High Court has dismissed the Application filed by the Plaintiff and thus, the injunction stands vacated.”*
