This is with reference to intimation filed by Company on 15th December, 2024, whereby we informed that a suit has been instituted before High Court, Delhi against the accepted trademarks, ‘Bookmyyatra’ and ‘Bookmyyatra.com’ by Yatra Online Limited. Further, the matter was listed for hearing on January 29, 2025 before the learned Joint Registrar and on April 29, 2025 before the Hon’ble High Court.
