1	Yatra Online Limited	14-12-2024	On April 29, 2025, the Hon'ble High Court directed the parties to file written synopsis in relation to the application filed by Plaintiff seeking interim relief and listed the matter for hearing on 20.05.2025. [It may be noted that as on date an ex-parte order dated 09.12.2024 is in operation.] Both parties have filed their written synopsis. On 20.05.2025, the Hon'ble Judge was not holding Court. The next date for hearing was given for 04.08.2025. We filed an application on 26.05.2025 seeking urgent hearing. The Hon'ble High Court preponed the date of hearing to 22.07.2025.	The delay in hearing on interim relief, which is essentially extending the ex-parte order dated 09.12.2024 led us to file an appeal bearing number 103/2025 on 29.05.2025 before the Division Bench of Hon'ble High Court. The Division Bench vide order dated 10.07.2025 has observed as follows: 1. This is an appeal challenging an ad interim order passed by the learned Single Judge of this Court in IA 47682/2024 preferred by the respondent under Order XXXIX Rules 1 and 2 of the CPC. 2. We are informed that the Order XXXIX Rules 1 and 2 of the CPC application is listed for arguments before the learned Single Judge on 22 July 2025. 3. In case the Order XXXIX Rules 1 and 2 application is finally heard on 22 July 2025, this appeal would not survive for consideration. 4. Accordingly, re-notify on 7 August 2025. The pendency of this appeal would not stand in the way of the learned Single Judge deciding the Order XXXIX Rules 1 and 2 application finally. 5. Mr. Saurabh Prakash, learned Counsel for the appellant, prays that the learned Single Judge may be directed to take up the matter on an earlier date. 6. We reserve the liberty with him to make the said request before the learned Single Judge. Thus, as on date, the matter is listed for hearing on 22.07.2025, on which the application seeking interim relief would be heard.
